WORLD'S LEADING SATANISTS: SAN FRANCISCO'S AQUINOS

In October, 1946, Michael Angelo (Michael the Angel) Aquino was born and raised in San Rafael, California. He likes to boast about his mother going to Germany after World War II, where she was impregnated by a Nazi SS officer, before returning to America. (He likes to march around in a Nazi SS officer's uniform.) Many investigators suspect his father was "the Angel of Death," Dr. Josef Mengele, because under Operation Paperclip, the CIA brought Mengele, hundreds, some say thousands, of Nazi officers and scientists to the U.S. Mengele, a psychiatrist who tortured/murdered thousands in Nazi concentration camps, was "sheep dipped." One of Mengele's U. S. "experiments" was Peter Tscherneff, a child in Harrisburg, Pennsylvania, with parents from Germany and Bulgaria. By age three, he spoke three languages. As one of Mengele's young mind-controlled sex slaves, Peter had no recall of Mengele or his multiple personalities, professionally called dissociative identity disorder, until he fasted and lost over 50 pounds in the spring of 2003. This caused "movies in his mind" to be triggered, as he recalled being used by Mengele, along with Cliff Lardinios and Rocky Muldon, to kidnap some Bay Area children, including Kevin Collins from San Francisco in early 1984. Aquino was also involved in the child's kidnap.

Aquino, a pathological liar and sociopath, and Lilith (Hebrew for Queen of the Witches) were exposed for sexually abusing daycare children at the Army's San Francisco Presidio Base in 1982-83 and in 1987-88. 1. I was subjected to the control of Michael Aquino in 1984.
